Are you among the 70% who have thought about it or the 30% who have acted on it?

What is going to happen to you or a loved one if you or they are hospitalized and can't express wishes related to healthcare? Is it likely that you are among the 70% of people who *realize* they need an "advance healthcare plan"? Or, are you among the 30% who have discussed your wishes with your family or loved ones and put them in writing? Advance healthcare planning helps your loved ones and healthcare providers honor your goals and wishes if you are unable to speak for yourself.



Daniel and Miriam Baird thought a lot about it after hearing stories of friends who had not made healthcare decisions and whose families were not only stressed by the medical emergency, but also unsure of how to handle all of the decisions that needed to be made on behalf of their loved one.

Miriam's parents had just moved to Winston-Salem from Los Angeles and her father had health issues. "We were in and out of doctors' offices," says Miriam, "and many times asked, 'does he have a living will?' and our answer was always, 'no,' so we felt like we needed to do something not only for our aging parents but we realized we needed it for ourselves too, so we asked, 'How do we get started?'"

The Bairds attended one of Hospice & Palliative CareCenter's "*Got Plans?*" workshops and commented about their experience. "It was so well-organized with worksheets and great information," commented Daniel. "They sent us home with everything we needed to get started. We worked on it with our parents and with each other. We feel so much better now about having all of that on record."

"It is such a great relief," says Miriam. "We didn't want to put this person that we love so much in a position of making a decision during what would be a very hard time. And it is such a relief. It makes it easier on everyone."

The hospice movement began in the United States in the mid 1970s and by 1977, our founders had fully embraced the hospice philosophy. They believed deeply in a holistic approach to care at end of life that would allow patients the ability to die at home, pain free, surrounded by family and personal treasures. They embarked on a grassroots effort to establish hospice care in our community. They were visionaries, trailblazers, and above all – a group of compassionate individuals who couldn’t be stopped. In August of 1979, they had established Hospice of Winston-Salem/Forsyth County, Inc. and provided care to North Carolina’s first hospice patient.



Thirty-five years later, we remain proud and committed to honoring that vision. Helping our patients and their families live fully and comfortably, at home, with medical, emotional, spiritual, and social support – replacing pain and fear with hope – that’s our mission. We are firmly committed to excellence and to providing the highest quality care. While in recent years the hospice industry has evolved and new hospice care providers have emerged, we have remained a pacesetter and leader. In fact, this year Hospice & Palliative CareCenter was a recipient of Hospice Honors, recognized as one of our nation’s highest quality hospice providers by Deyta.* More specifically, when compared to 1,700 hospice providers in the US, we were among only 39 hospice providers to receive Elite Status for consistently providing the highest level of satisfaction as measured by the caregivers. That is why we hope that those in need of hospice care will ask for us by name.

We are encouraged by the growing number of people turning to us and trusting us for care. Yet, far too many families continue to tell us that they wish they had called sooner. So as we celebrate both National Hospice Month in November and our 35th anniversary, we realize the need to continue in our efforts to educate the community. REMEMBERING *Helps Healing*

The holidays can be an especially difficult time for those who have lost a loved one. As you face traditions and events associated with the holidays, it is important to take care of yourself and give yourself permission to say no, to create new traditions, and to create some time and space to remember your loved one who has died.

One way of remembering a loved one who has passed away is to consider a ritual in their honor. Ritual is a helpful way to transform a lifetime bond so that your once vital connection lives on in a new way.

As the holidays unfold, you may consider some of the following rituals helpful:



- **Light a candle.** The candle flame is a universal symbol of vigil and honor. You can create your own candle lighting ritual. Tell a story, read a letter to your loved one, or just observe a moment of silence.
- **Create a sacred space.** Assemble a “memory box” of photos and small personal items to open on special occasions or when you simply want to reflect. Or create a home altar as a space for reflection in the privacy of your own thoughts. For public honor, arrange to plant a tree or donate a bench to a nearby park.
- **Walk, run, or ride for a cure.** Gather a team or go by yourself to raise funds for research in your loved one’s name. Many national organizations hold walks and runs in our area. Or consider our Annual Hospice Hope Run/Walk and begin training and dedicate your participation to your loved one.
- **Support their passion.** Host a gathering and serve your loved one’s signature foods. Or play their favorite music and games. Make a contribution to your loved one’s favorite charity or club.

HOSPICE & PALLIATIVE CARECENTER - your "hospice" for 35 years



Our roots in Winston-Salem date back to 1977 when our founders began planting seeds for this movement called hospice. In 1979, 35 years ago, we admitted North Carolina's first hospice patient. Today, Hospice & Palliative CareCenter serves over 400 patients and families in 13 counties from offices in Winston-Salem, Mocksville, Walnut Cove, and Salisbury.

This year, as we commemorate our 35th anniversary, we have many reasons to reflect, countless patients and families to remember, many stories to share, and the opportunity to remind you why you chose this hospice—Hospice & Palliative CareCenter—as *your* hospice.

For many people "hospice" is a generic term that describes end-of-life care, and maybe even the name of the organization to call when you are ready for that care. Many people still think that all hospices are the same and that we are somehow linked. Yet, in truth each hospice is a separate organization and there can be differences. To us, hospice is the cornerstone of our programs and services and the core service upon which Hospice & Palliative CareCenter was built. Under our Hospice & Palliative CareCenter umbrella, there are additional programs and services – from helping with advance healthcare planning, to finding guidance and support when learning of a life-limiting illness, to embracing hospice care when facing a prognosis of six months or less life expectancy, to bereavement and grief counseling after the death of a loved one.

After 35 years of service, ***we want people to ask for us by name – Hospice & Palliative CareCenter.*** It might surprise you that after telling a friend about your personal experiences with Hospice & Palliative CareCenter and suggesting they call us to learn more, they end up with another hospice provider. It happens more often than you would think. Some people may ask, "Why does it matter which hospice cares for me or my loved one?" We want you to know the answer to that question so you can be informed for yourself and for others who might ask.

Here are just a few reasons to choose Hospice & Palliative CareCenter:

Patients and families are provided care in all settings, and at any level of care.

- Expert routine Hospice Care at home
- Respite care for caregivers, whereby patients are welcomed into our Kate B. Reynolds Hospice Home in Winston-Salem or our Glenn A. Kiser Hospice House in Salisbury
- For acute symptoms, when medically necessary, around-the-clock care in either of our Hospice Homes – or for our patients who would rather stay at home, around-the-clock care in your home

Experience: As the first hospice in NC and one of the region's largest and most experienced hospices, we provide care to nearly 400 hospice and palliative care patients each day. An extraordinary number of our staff are specially trained and certified in hospice and palliative care.

On-Call Staff 24/7: We are available to answer questions or address concerns day or night – 7 days a week.

Expert Emotional Support: We offer above and beyond emotional, spiritual, and social support with full-time chaplains, social workers, and professional grief counselors who are expertly trained in hospice and palliative care.

In-House Pharmacy: Our fully staffed, in-house pharmacy responds to medication needs immediately and makes home deliveries.

Volunteers: Our 400+ volunteers provide emotional support, assistance, and friendship for patients and families.

Community Bereavement: Grief support helps those served by hospice as well as anyone in the community facing a death related loss.

Large geographic coverage area: We cover 13 counties from 4 offices spread throughout the region: Walnut Cove/Stokes County, Winston-Salem/Forsyth County, Mocksville/Davie County, Salisbury/Rowan County.

We encourage patients and families to choose a hospice like you would choose your doctor. Ask for us by name because all hospices are not created equal.

Individual beneficiaries of retirement assets are required to pay income taxes on those assets and possibly estate taxes as well, whereas charities are not. So, dollar for dollar, more of your money would go towards a charitable cause than if you designated it to an individual.
- It matches your priorities: Because you can choose multiple beneficiaries for different percentages, you can make gifts at death that are in line with your priorities. For example, you could leave 75% to your children and 25% to The Hospice Foundation. No matter how the value of your account fluctuates, your commitments remain in line.
- It is easy: No trips to the attorney's office or new legal documents are required. Just contact your financial advisor or retirement plan administrator to complete your beneficiary designation form. We can provide you with The Hospice Foundation's tax ID for your form.
- It is free: You are making a major gift to support our mission but are still able to use the assets while you need them.
- It makes an impact: Many people can make a much larger gift through an estate commitment than they ever could during their lifetime. It is your opportunity to make a lasting impact and lasting difference for years to come.

“We started the ride as a way to give back to Hospice & Palliative CareCenter for all that they did for Ginny back in 2004. She was an adventurous and active woman and she inspired me to organize this ride,” shared David Cornelius, her son-in-law. “Before she died, I had asked her what she thought about me getting a motorcycle. She told me, ‘You only live once.’”

David admitted that organizing the ride is a lot of work, yet he and his wife Terri were so moved by the care Hospice provided when Ginny had lung cancer that it felt wonderful to give back. “We’ve raised \$9,000 over the nine years we’ve been hosting this event. We would like to reach \$10,000 this year.”

Since Ginny’s care, Terri’s father Bob, who had Alzheimer’s; David’s mom Dot, who had colon cancer; and most recently, Terri’s brother Mike have all benefited from Hospice & Palliative CareCenter.

The ride, held on Saturday, October 11, marked the 10th Annual Ginny B Ride. Prior to the ride, David announced that this year would be the last. “This year’s ride will be bittersweet. After 10 years, we are ending the ‘official’ Ginny B rides. It was a very hard decision, yet we feel that 10 years is a good stopping point for the ride,” shared David.

This year’s route was the best ever, leaving Honda of Winston-Salem on Stratford Road, traveling up Country Club road to Lewisville, then onto Shallowford Road into Yadkin County. From there, riders traveled some of the prettiest roads over to Shiloh General Store in the Amish area of Yadkin County, then back roads towards Wilkesboro, before heading northeast to Stone Mountain State Park for lunch.

“We are very thankful to David and Terri for their efforts and generosity. They have certainly gone above and beyond on our behalf,” shared Beth Bryant of Hospice & Palliative CareCenter. “We are glad we could be there for their loved ones and so very appreciative that they wanted to give back in this way.”


